# Newborn Physical Examination

**MSAP4031** 

This module provides the opportunity for midwives and allied health professionals to come together to extend their knowledge of neonatal physiology and gain the competence to carry out a full newborn physical examination as required by the National Screening Committee standards (2008).

There is a growing need for Registered Midwives and other allied health professionals to extend their role in the field of newborn examination and screening for health. In extending their field of practice, midwives and allied health professionals will, upon completion of the module, be able to offer informed choice to clients, improved satisfaction and an improved service.

# **Pre-requisites:**

Applicants must be:

- A registered midwife, nurse or allied health professional with at least one year's post registration experience.
- Engaged in the care of neonates sufficient to fulfil the module learning outcomes & clinical competencies
- Have written consent from their employer to support the practice element of the module.
- Have a suitably qualified preceptor i.e. a Consultant or Registrar grade Paediatrician; a Midwife or allied health professional with a current neonatal health assessment/ newborn physical examination qualification.

\*To enter at Masters level you should include with your application evidence that you have achieved a good degree (2:2 or above) within the last 8 years. OR provide evidence of achieving a degree with less than 2:2 classification in the last 8 years and complete the supporting statement in the application form to explain why you think you should be able to study at level 7 and provide a reference from an academic to support your ability to study at level 7. If you cannot meet the above criteria or you are in any doubt about this point, you should discuss it with the module leader before applying.

### Assessment:

Portfolio of Evidence - Minimum of 5,000 words

Observed clinical examination to assess competence in practice
